

Did you ever forget to thank someone? It's such an easy for-profit corporation. Our assets were about \$500,000, mostly small funds. The board and a staff of two began running the Foundation and administering the Education Improvement Tax Credit program for the state. We owe our board thanks for struggling with the growing pain of a new organization; and the staff for their direction and the dedication they gave us on a shoestring budget.

> And now, we have 150 funds, 4 ½ million dollars in managed investments, and another 2 million that will be granted this year for a new hospital. At the end of 2012 our total assets were about 9 million dollars. The staff has grown to eight counting both full time and part-timers. We serve all of the counties of the Endless Mountains and the others nearby. Funds located in England, funds serving organizations across our country and as far away as Japan, all have their roots right here. Who do we thank for this success?

Over the years various endowments have been established at The Community Foundation by local attorneys who are



Peoples Funds Improvements at Abington Heights

Adventures in "The World Capitol of Volunteerism"

Twelve years ago when my husband John and I first moved to this area I worked as a reporter where I heard Lee Smith, then County Commissioner, proudly refer to this area as "The world capitol of volunteerism." The truth of that moniker became clear as my job placed me at the scene of local news. There was nary a breathing resident of any age, human or four-legged who did not volunteer. The fire fighters were volunteers, the Blueberry Festival supported the library, ponies pulled carts in parades, dogs gathered sheep at festivals. I also did communications work for the League of Women Voters - who could resist the good company of such bright, fun, well-informed women? We found Salts Springs Park next on a trip up Falls Brook with our grandkids, and soon John was on the Friends of Salt Springs Park board which he later led for four years, and I was serving hot dogs at their annual Celebration and helping Heidi Randall add gardens. Capturing our History: Friends of Salt Springs Park Celebrate 20th Anniversary

In 2014 the Friends of Salt Spring Park will celebrate 20 years of restoration and conservation of 842 of the most beautiful acres of Susquehanna County. The anniversary celebration will include the release of commemorative book. Salt Strings: How a Committed Group of Volunteers Keeps a Park Alive While Honoring the Past. The book will be available for purchase in April 2014. Anyone interested may sign up to receive details at friends@epix.net. The volume is being compiled from interviews and oral histories collected by the Friends' Historical Committee. It will feature photographs, memories, descriptions of key hurdles and triumphs, and accounts by the people who have, and who continue to frequent and support the Park.

The Friends organized in 1994 as an all-volunteer citizen nonprofit to rescue the former Wheaton family homestead in Franklin Forks, PA. The Wheaton's settled their 405-acres in the late 1830's and passed it down through generations until in 1972 when they sold it to the Commonwealth of Pennsylvania to be used as a state park. But the property suffered a slow deterioration as state agencies were unable to maintain the buildings or develop its potential. From that low point the Friends organized and raised funds









to make repairs, and to purchase and protect an additional 437 adjacent acres. They hope to add more.

In addition to preserving open spaces, they have worked to restore the eleven traditional buildings on the lands, a collection of period tools, artifacts, and homestead practices that teach us so much about our pioneer settlers' way of life. The Friends now offer familyfriendly education programs on the environment and local agricultural history. They include nature hikes and forays for local children, traditional music performances, classes on openhearth cooking, organic gardening, spinning and weaving, nature photography, and traditional uses of plants, herbs, mushrooms.

The Wheatons welcomed visitors and understood that land so uniquely endowed should be shared. Today the Friends perpetuate the tradition of preserving and sharing the Salt Springs area for today's families and future generations.

The Friends have a Legacy Society and an endowment fund managed by The Foundation. People wishing to support conservation of natural lands, free, wholesome family recreation, environmental education, and historical preservation are urged to purchase the commemorative book and to contribute to The Friends of Salt Spring Park Fund. 

The Women Helping Women initiative was established in 2012 to address the needs of women and girls, and remove their barriers to autonomy, financial security, and safety. The initiative built upon the work of Judy Ventresca who wished to open up her own women-centered endowment fund to more participation. A leadership committee was formed, and the first annual Fall Breakfast was held in October. Seventyfive women attended the event which featured a presentation by screenwriter, author and actor, Angela Shelton. Since that kick-off, the value of the Women Helping Women Fund has tripled by new donations and pledges, and its grant making ability has also tripled.

The New Year brought great loss and sorrow to our community when we were shaken by the death of a beautiful young woman who had experienced domestic violence. Domestic violence victims often experience isolation and loss of control that hold them hostage and powerless in a relationship. Most often family members and friends are completely unaware of the situation.

With this concern in mind, the Women Helping Women Fund leadership designated Dating Violence Prevention Education as a primary focus for the year 2013. We targeted 2013 grants to three agencies which provide educational programs in the schools: Care Net, Women's Resource Center, and Trehab.






