FROM THE PRESIDENT





PETER QUIGG President

I've always been fascinated by history. Nine years ago when I began working at the Community Foundation we managed 45 charitable endowments. Donors and I discussed the lasting effect these funds would have upon future generations. Today we are managing more than 170 endowments, benefiting organizations from Manhattan to Tokyo. We work

for donors located from England to Texas. Almost daily we create tomorrow's history, and importantly, we carry forward charitable traditions begun decades ago which literally have no end in sight.

Recently the Dimock Community Workers transferred to us their college scholarship created in the 1930's by Francis Cope to assist graduates of Dimock Vocational High School. In the 1980's Dimock Community Workers Le June Ely, Martha Locey, Lucille Fuller, and Betty Mills among others, breathed new life into that scholarship to benefit today's graduates of Elk Lake School District. The Cope family was also a founder of the Susquehanna County Library and Historical Society which in 2007 transferred their long-standing endowment to our management.

We currently manage five funds that benefit the Tunkhannock Public Library, and all Wyoming County libraries. The latest, the Asheld and Kennard endowments, arrived thanks to efforts by County Commissioner Judy Mead. The fund honoring Frances Kennard was established in 1930. Now valued at \$100,000, it endures to benefit libraries. A few years ago Mark and Sandy Wilmot transferred to our management the Mountain View School District Library Fund established in the 1970's. Sandy was also instrumental in establishing with us the Clifford Township Historical Society Fund in 2008.

Over the years, we've facilitated many projects to benefit our Affiliate School District Foundations. In 2007 the Tourje family of Forest City transferred to us their memorial endowment honoring family matriarch Jessie Osgood Tourje. It supports special unfunded school district projects. In 2009 the Keller family brought us their college scholarship which honors coaching legend and family patriarch Dutch Keller. Recently Lakeland School District Superintendent, R. Scott Jeffery, brought under our management the Dana Rymer Battenberg Scholarship established by H.A. Willman with \$5,000 in 1920. Now valued at nearly \$65,000, the Foundation will respectfully adhere to Mr. Willman's criteria to benefit the students of Lakeland into the next century.

The John Lyons Fund was established in the same era, in 1936 to support several Montrose charities. Earlier this year the Montrose Cemetery Association voted to transfer their portion of that fund to our management. It joined another Foundation endowment which helps to maintain that historic final resting place of local families.

Each of our funds, new and old, is important and unique. Each adds to a deep and growing tradition of local philanthropy. It has been 94 years since Mr. Willman established his scholarship. As we create folders for our new endowments and place them in our archives, I wonder who may be writing a similar article in 2108 about this year's Joan O. Peters Memorial Scholarship, or the Child Safety & Advocacy Fund in memory of Kevin Boyle, or the Endless Mountains Habitat for Humanity Scholarship, or the Elk Lake Visual & Performing Arts Fund.

The documentation of history takes many forms. Our endowments record and reflect the most personal and cherished wishes of our donors. We thank them for entrusting us with their preservation and fulfillment.




### GRANTS

Big increases in 2012 and 2013 grant growth were funded by Cabot Oil & Gas and other natural gas businesses rallying to support a new hospital. Our 2013 grants totaled \$2,717,535.

A steady rise from 25 funds in 2003


to 163 funds in 2013.



### TOTAL REVENUE

Average annual revenue of more than \$2.4 million per year for the last five years, excluding hospital funding swings.


A Note on Expenses: Our expenses of just 6% of revenues, places the Foundation among the most efficiently administered nonprofits. Total 2013 expenses were approximately \$191,000. These are paid by a 1% charge for endowments, a 2% charge for scholarships, and a higher fee for administering funds for the state of Pennsylvania.





### INVESTMENT ASSETS

Nearly the entire amount given in hospital grants was replaced by new donations in 2013 to end the year with \$6,289,956 in investment accounts.



### TOTAL ASSETS

The combination of investments and fixed assets, real estate and equipment remained constant at slightly less than \$9 million.



#### INVESTMENT RETURN

Investment accounts earned a 17.8% return for the year and an average return of 13.5% for the past five years. Returns are net of all investment expense and are tax free.

### Does a Charitable Remainder Trust Make Sense For You?

Gifts to qualified charities, such as the Community Foundation of the Endless Mountains, are deductible for income tax, estate tax and inheritance tax purposes. There

are several ways to structure charitable gifts, with one of the most popular being the creation and funding of a charitable remainder trust. This type of trust allows you to retain an income interest in the property set aside for charity while giving you a current income tax deduction and and inheritance tax purposes.

There are two types of charitable remainder trusts: the Charitable Remainder Annuity Trust and the Charitable Remainder Unitrust.



1. Charitable Remainder Annuity Trust. This is a trust that pays a fixed dollar amount (at least five percent of the value of the property contributed to the trust) each year to one or more recipients (you, your spouse or other beneficiaries chosen by you) for life or for a term of years — maximum twenty years, and then upon the termination of the trust the remaining proceeds are distributed to one or more charitable organizations selected by you, such as the Community Foundation. The tax benefits include: (i) a current charitable deduction (subject to Adjusted Gross Income limitations) for the present value of the remainder interest; (ii) the capital gain on the sale of assets held by the trust is not recognized;

and (iii) the trust assets are not considered part of your estate for estate tax purposes.

2. Charitable Remainder Unitrust. This is a trust that pays a fixed percentage (at least five percent) of the value of the trust's assets each year (as valued at the beginning of each year) to the recipient(s). The charitable benefits are the same as an Annuity Trust, with the primary difference being the annual payment to the recipient is not a fixed annuity amount but will increase if the value of the trust increases or will decrease if the value of the trust decreases.

For example purposes, lets assume that a person age 65 (the "Grantor") establishes a charitable remainder annuity trust reducing the size of your estate for estate with a \$500,000 contribution of closely held stock (with a basis of \$100,000), and a 5% annuity payment back to the Grantor in the amount of \$25,000 payable once a year. Also assume that the stock is sold soon after it is contributed and that upon the Grantor's death the trust agreement provides that the funds will go to the Community Foundation.

> Based upon those assumptions and applying the appropriate IRS table, the Grantor would be entitled to a charitable deduction of \$205,000 that can be claimed in the year of funding, but if the AGI limitations prevent a full deduction in the first year, the unused deduction can be carried forward up to five years. No capital gains would have to be recognized upon the sale of the stock in the year of sale, even if the stock's basis (what the Grantor paid for the stock) is much less than its sales price. Each year the Grantor would receive \$25,000 from the trust, which would be subject to income tax, first as ordinary income to the extent of the trust's interest and dividends for the year, with the balance taxed as capital gain rates. Upon the Grantor's death the trustees will distribute the balance of the trust fund to the Community Foundation and the full value of the trust is excluded from the Grantor's estate for estate and inheritance tax purposes.

> If you were interested in making a gift to the Community Foundation, but were desirous of retaining some benefit in the gifted assets for yourself or a family member for a period of time before the gift is turned over to the Foundation, a charitable remainder trust would be an ideal option. # The Community Foundation and the Susquehanna County Bar

All attorneys are required to take a certain number of hours of continuing legal education (CLE) each year. The Pennsylvania Bar Institute (PBI), the education arm

of the Pennsylvania Bar Association, is a provider of these courses. About four years ago, the Susquehanna Bar Association needed a new location in which to host its CLE's, as the county had run out of space to hold these much-needed courses. The Community Foundation building was the answer to our needs.

Through the assistance of Earle Wootton and the PBI staff, we were able to move our courses to the Foundation location and thereby provide to our members the premier venue in the Commonwealth. Not only were we able to have a wonderful location staff — the very helpful employees of the Foundation — but we were also able to offer our members their educational credits in a well-lit, learning friendly, and beautiful environment.

After three years, Mr. Wootton said he could do better, and as a result constructed a whole new room dedicated to the

Bar's needs, with comfortable chairs, work tables, in-room refreshment facilities and adjacent restrooms. It is without a doubt THE location in which to listen and learn in all of

In discussions with the Susquehanna County Bar Association officers, the Foundation directors indicated they could offer even more to the legal community. Rooms are now available to allow private discussions with clients, trial preparation for cases being litigated down the road at the courthouse, space to meet with and take the depositions of witnesses and many other uses.

The President of the Pennsylvania Bar Institute and its Executive Director recently journeyed up from Harrisburg to view the Foundation building. After a tour of the building and a review of the multiple ways members of the legal community could make use of the facility, it became apparent why this is often referred to as a place that cannot be adequately described, but has to be seen to be fully comprehended.

Were it not for the foresight of Earle Wootton in saving and developing this beautiful old structure, the legal community of Susquehanna County and the surrounding area would be lacking a facility in which to continue our educational requirements and to meet and prepare for extended litigation. Martha Locey recalls that the Dimock Community studying birds. Workers began in her parents' generation. Religious affiliation and attendance at religious services correlates with giving twice the dollar amount of non-religious donors, and three times the percentage of their income.



### Cabot Oil & Gas: Tools to Succeed at SCCTC

Susquehanna County Career & Technology Center (SCCTC) has doubled its floor space and has been adding new career programs at breakneck speed. They are responding to students looking for economic opportunity, and to industries crying out for skilled workers. SCCTC had a record number of 139 graduates in 2014. Yet, even with training brought right into their community, many of SCCTC's students and their families find the costs related to technology training a barrier. Safety equipment, industrial tools, uniforms and hard-toe shoes, automotive tools, cosmetology kits, certification exams all can cost lump sums of hundreds of dollars these families just don't have. Filling their gas tank or buying lunch is a struggle for some. This is the critical gap being filled by Cabot Oil &

This is the critical gap being filled by Cabot Oil & Gas. Their \$50,000 Cabot Oil & Gas Scholarships for SCCTC students are directed through the Foundation's

EITC program. This year it helped 104 students with learning tools assistance. The result is good news for everyone: More than 82 percent of students leaving the center to work in their field of study have jobs awaiting them.

# Futures Powered by the Sun

With Community Foundation EITC funding of \$42,000 donated by Peoples Security Bank, Montrose High School has begun construction of a solar pavilion. Once provide electricity to the school and athletic facilities. The project was proposed by teacher William Host. Mr. Host's plans were supported by the school board with an initial allocation of \$4,500. Host then sought community support to complete the funding.

The process of constructing an actual building required blueprints. Students enlisted a volunteer, contractor John Puzo, to do the drawings. Carlo Schneller, a professional engineer signed and sealed the plans. Eric Lewis of Spectrum Electric made the final connection with electrician Jamie Holbert overseeing the students on electrical code requirements. Bruce Costelli of the Susquehanna County Career & Technology Center conducted a class on hand tool safety and protection with students.

The pavilion construction, and eventual connection to the High School utility grid will introduce students to the mechanics of solar energy, and electricity in general. completed, the new twelve by eighteen foot structure will It will enhance students' study of physical science, electronics, physics, general science, and architecture in the Junior and Senior High School. The practical physics club will also use it as a learning resource.

> Once the lessons are learned, Mr. Host expects the pavilion will be a permanent asset to the school, providing shade and cover for relaxation and picnics by school groups and sports teams.

"Above and beyond" projects that enhance students' learning are exactly what EITC special projects funding is all about. They have been popular in gaining support from Foundation corporate EITC donors. Past EITC special projects have also benefited Susquehanna Community and Abington Heights School Districts.

# Bright Ideas That Last

Time is the great multiplier of charitable endowments. An example of this is the Dana Rymer Battenberg Memorial Scholarship which was recently transferred to the Community Foundation from a private foundation. It was established in 1920 for \$5,000 — which must have been a large sum for that day. Yet, after providing scholarships for nearly a century, it is currently valued at \$65,000 and will award a \$3,000 scholarship in 2014.

The man with the bright idea to established the scholarship was H.A. Willman of Jermyn Borough in Lackawanna County. The foresighted Mr. Willman was an early electrical engineer who established one of this region's first electric light plants, The Independent Electric Light Corporation. His store was noted in local newspapers as installing one of the first commercial steam heaters as well. Willman's enterprise grew to include a railroad ticket office as the railroad industry was bustling. Like many of today's philanthropists, Mr. Willman was active in business and civil society. He served on the Jermyn Board of Trade, was also a member of the Merchant's Protective Association, and a trustee of Jermyn's very first and still active fire company, Crystal Fire Company No.1.



Willman's goodwill continues to shine to benefit Lakeland School District students of "high moral character who have achieved the highest grade point average of any student, and who will attend college or a post-secondary degree program." 

### Lyons Fund Preserves Cemetery and History

In January, 2014 the Foundation was very pleased to bring Montrose in 1818. He established a surprisingly successful under its stewardship a portion of the John Lyons Memorial bookstore despite the town's very early state of development Fund which has survived since its origin in 1930.

This portion of a legacy from a distinguished founding family is dedicated to the support of the Montrose Cemetery. It memorializes John P. Lyons (1858-1939) who loved animals and was a first officer of the Susquehanna County Humane Society which he organized in 1921.

The Montrose Cemetery itself is a 19th century treasure. Its oldest lawns, among towering hundred-year-old hemlocks are the final resting place of 52 Lyons family members. The Lyons family's endowment will help preserve that place and their own place in Montrose history. Some of their history is summarized below.

The first Lyons brothers arrived in Montrose from Massachusetts and had grandparents who were among those pitching British tea into Boston Harbor in 1773. Their father New England. Jerre Lyons arrived in 1819 and established a mercantile business consisting of a store, house and granary which brother Benjamin R. Lyons soon joined. Benjamin continued that business for 67 years surviving and reviving the store following historic fires and all the economic turmoil of a frontier town. He was himself a well-informed philanthropist who surrounded himself with a valuable library. Benjamin was among the first bank directors for the Bank of Susquehanna County established in 1837.

Four Lyons brothers fought for the Union during the Civil War, with only one returning home.

The Lyons family home, located at 315 Church Street, Montrose, was built in 1818. It is known both as the John Lyons House and the Sylvanus Mulford House after was a university trained physician who practiced medicine in its first owner. 

# A Stitch in Time Quilt Guild

mong the many enduring folk traditions of the Endless Mountains / is the art of quilting. It has roots in self-sufficient farmers and the Underground Railroad. Homemakers "made due" by reusing cloth scraps and feed sacks. When commercial blanket wool was reserved for the soldiers during wars, community-made quilts were raffled to benefit the Red Cross. Folklore tells us that escaping slaves were directed to freedom by the patterns on hanging quilts which signaled safe houses and travel routes. American history and regional history are stitched into its quilts.

Today's quilters appreciate this heritage, and remain fascinated with the puzzling and creative process that yields surprising beauty. Sandy Rinker, a spokesperson for Stitch in Time Quilt Guild, recounts that her mom was a doll maker. But she caught the quilt bug from her grandmother Ethel, a widowed mother of seven children who always had a quilt sheet stretched out, and from her Aunt Ester's "closet full of quilts". These memories, and her study of fashion design inspired her to the piecework she now favors.

Quilting is typically collaborative, and often philanthropic. The Stitch in

Time quilters have created lap quilts for Wounded Warriors, kids quilts for children's hospitals, baby quilts for neo-natal wards, quilted hand-washable dresses for Haiti's storm survivors, and colorful adult bibs for geriatric patients. They've raised cash for charities by auctioning off beautiful bedcovers and wall hangings. The Women Helping Women Fund has been a grateful recipient of their donations as well. # Donors Support Libraries

The Foundation is steward to six funds that benefit public libraries in Susquehanna and Wyoming Counties, as well as the two school libraries in the Mountain View School District. Two recently transferred funds were begun in the 1930's.

Since the Great Recession, libraries have been under intense financial pressure, making the need for ongoing philanthropic support still essential.

THE KENNARD FUND: "A little money" and a life's work

The history of Wyoming County tells us that Meshoppen's library is named for Frances E. Kennard, an early librarian who "left it a little money and spent her life

directing library activities."
That amount was actually \$1,000, a significant bequest for the 1930's Depression era. Miss Kennard's family owned the Kennard Hotel, a three story Victorian which eventually became the first site

of Tyler Memorial Hospital. She had

attended Drexel University Library School in Philadelphia, and was assisted by other educated locals. These included Mrs. John Bunnell, a veteran Tunkhannock teacher and graduate of Mansfield "normal school", and Mrs. Leslie Ellsworth who helped keep the library open after school hours.

The very first Meshoppen library was started in 1900 on the site of the current Bridge Restaurant. Belle Hankinson Woodward, a graduate of Bucknell University, installed it on the second floor of her father's store. Over the years that original collection was shifted from a vacant church building, to the municipal building, and eventually to the second floor of a bank building at the corner of Canal and Auburn Streets where it has served as a branch library since 1975.

Miss Kennard's "little bit of money" along with a great deal of work by many library friends over 114 years, today amounts to nearly \$97,000. The Foundation is delighted to be the new home and 21st century financial guide to this historic endowment.



Asheld Endowment

An endowment to benefit the Wyoming County Library Board has been established with the Foundation. Known as the Asheld Memorial Fund, it was placed in our trust with little information regarding the original donors. Research on the Asheld family in Tunkhannock has uncovered a family that are likely candidates, given their prominence in local business, civil service, and politics.

Homer B. Asheld who lived in Tunkhannock from 1887 until his death in 1965 was a son of Pierce Asheld and Helen Miller Asheld. Pierce Asheld is described in local newspapers when he died in 1928 as "one of Tunkhannock's best." His four children were Lillian, Homer, Horace, and Clarence. Homer appears often in Tunkhannock and government records. He served in the military during World War I and he was married. He worked at a glass cutting factory and later owned a photographic studio on Warren Street which he sold in 1931. His

brother Clarence, who served at least once as a census taker, is reported in 1894 as selling a book of 500 photographic images of the world. Homer appears on the Wyoming County payroll as an Auditor in 1925. In 1928 he was appointed Tunkhannock's U.S. Postmaster, a position he held for several years. An amusing incident reported in the news recounts that as Postmaster he had the duty of auctioning off to the highest bidder a clutch of unclaimed chicks that had arrived in the mail. Homer was also member of the Order of Odd Fellows and served for a time as Chairman of the Wyoming County Republican Party.

Though the details of the Asheld history remain sketchy, the Asheld Endowment, now valued at over \$41,000 survives to support its donor's wish that local libraries will endure.

## "All In" on Behalf of Her Library

Two passions of Tunkhannock community leader Maggie Cartwright came together with the transfer of an existing Tunkhannock Public Library Endowment to the Community Foundation in 2009. Maggie had been an active board member of both organizations and she quickly saw the benefits of managing the library's fund locally and with conservative investment by the Foundation. Maggie's efforts, along with a vibrant raise funds to build and renew that and faithful band of library supporters, endowment. Supporters gather and have over the years continued to overflow the library's parking lot at



each annual food and wine tasting and other events. The Tunkhannock Library Friends Fund, which also continues to grow robustly, is also maintained by the Foundation.

Maggie does nothing half way! Her personal estate plans include a legacy permanent endowment that will also benefit the Tunkhannock Public Library. Though none of us is immortal, our goodwill, like Maggie's, in the form of an endowment, can perpetually energize a nonprofit we love.

### Mountain View Library Fund: Focus & Consolidation

Since 2009 the Foundation has managed the Mountain View School District Library Fund to benefit both the elementary school and the high school libraries in that district. The endowment was originally established in 1994 by an avid reader, Mark Wilmot of Union Dale who donated the stipend he received as acting treasurer for the Mountain View School Board. The Community Foundation was able to consolidate Mark and his wife Sandra's gift with gifts of other school district advocates and create some synergies that benefit all involved:


